Judge Montgomery is the longest serving civil judge in Dallas County by at least 8 years. She firmly established herself to be one of the more significant and influential leaders in the area, when in the 2006 nationwide election she was among the top three vote getters in percentage and votes for Dallas County. She was first certified in 2003 and recertified in 2009. In 2006, Judge Montgomery received the Presidential Commendation from the State Bar of Texas for individual leadership in improving justice. In addition to her judicial leadership, since 2006, Judge Montgomery has coordinated and moderated numerous free seminars for continuing legal education credit in both creditor-consumer rights and professional ethics, as well as co-authoring a paper "Landlord/Tenant Rights and Ethics."

By any measure, Judge Montgomery is the benchmark for integrity and justice in matters that are paramount to Dallas citizens. When in her court, we are assured equality, fairness and objectivity. Not surprisingly, Judge Montgomery's success has neither been easy nor overnight. For example, in 2002 she was the lone Democrat elected in any Dallas County-wide race, the first to do so in sixteen years. Judge Montgomery has forged a record in the last seven years that is rivaled by none in Dallas County. Even so, she will face a well-funded and aggressive opponent in the general election on November 2, 2010. Judge Montgomery represents the best of Dallas. We are fortunate to have her represent us.
